



RULES OF THE OFFICIAL ANNOUNCEMENT FOR POLINIZA DOS 2019 (URBAN ART MEETING)

1. PURPOSE

The Cultural Activities Department of the Vice-Rectorate of Students, Culture and Sport of the Universitat Politècnica de València organizes, within the schedule of activities for POLINIZA DOS 2019 (The Urban Art Meeting), an event featuring artistic interventions on campus, either by making murals on an architectural surface and that is related in terms of plastic materials as well as symbolically to its urban environment, or with ephemeral interventions in space.

2. REQUIREMENTS FOR PARTICIPATION

The official announcement is open to all artists over 18 years old interested in taking part individually or collectively.

Those selected by the jury must present a project with the aim of creating a pictorial wall mural from 13th to 17th May 2019 inclusive, every day from 10 am to 6 pm on the walls authorised for this on the Campus de Vera of the UPV.

3. APPLICATION FOR THE REGISTRATION AND TIMELINE

The period for registration and submitting applications is February 1 to March 21, 2019, both dates inclusive. Applicants must fill in the registration form available on the website www.upv.es/poliniza and they can include in it any link to their digital portfolio or website with the work presented.

4. PANEL OF JUDGES

The following representatives of the Universitat Politècnica de València will make up the panel of judges: the Vice-Rector for Students, Culture and Sport, the Director of the Office of Cultural Activities, the Vice-Dean of Culture in the Faculty of Fine Arts, a professor of the School of Building Engineering, the commissioner of POLINIZA DOS, the coordinator of POLINIZA DOS and a representative of the students.

After assessing the information provided, the panel of judges will select the participants for the event. At the same time, they must present a sketch of the project within 15 calendar days from the communication of the resolution and they will commit to creating it in accordance with the terms contained in these rules.



The panel of judges shall function as set out in the rules of the collegiate organizations of Law 40/2015 on the Legal Regime of Public Administration.

5. SELECTION CRITERIA

The judges' assessment will take into consideration the following criteria:

1. Career and/or academic and art education
2. Participation in exhibitions, events, festivals and other urban art shows
3. Grants and prizes
4. Continuing work in performing artistic interventions in public spaces

6. DECISION

The panel of judges will evaluate and suggest the winners and submit the proposal to the Rector for resolution. The winners will be notified within 5 days.

The winner of the contest will be announced through the link 'Cultura' on the website www.upv.es (www.upv.es/entidades/ACU/index-es.html) and the POLINIZA DOS website (www.upv.es/poliniza/).

7. PRIZE

The grant total is 3.600 euros, which are charged to the consignment 009010000-422-47110. The gross prize for each artist or group will be 600 euros (they will be paid by bank transfer) for every piece of wall art completed. There will be a maximum of 6 individual or collective pieces. In addition, the organization covers the travel, board and lodging expenses of the selected artists. Furthermore, the materials needed for the project will be provided to the participants. Prizes are subject to the appropriate tax deductions.

8. CONDITIONS FOR IMPLEMENTING THE PROJECT

The artists will transfer the rights of their works to the UPV, who may make free use of them and determine their time of stay in the exhibition space, which in some cases may be longer than the time elapsed between consecutive editions. For his part, the Vice-Rectorate of Students, Culture and



Sport is committed to disseminating the prize through the usual channels and will provide the infrastructure and materials needed for the implementation of the selected project. At the same time, the author or group of authors are committed to completing the project presented within the established timeline.

9. ACCEPTANCE OF THE RULES

The participation implies both total agreement with and acceptance of these rules.

10. COPYRIGHT

The authors of the proposals presented will transfer all rights of reproduction, transformation and public communication free of charge to the Universitat Politècnica de València, without time limitations and on a global basis. For the purpose of this concession, transformation means the simple inclusion of the work presented in the database of the vice-rectorate.

11. DATA PROTECTION

Data Protection: In compliance with Regulation 2016/679 of April 27, 2016 related to the protection of physical persons with respect to personal data processing and the free circulation of this data, you are hereby informed that the data controller for this data is the Universitat Politècnica de València and that the personal data contained therein shall be processed in accordance with the purpose of administratively managing the requests from the financial aid scholarships from the Universitat. 12. APPLICABLE APPEALS AGAINST THE RESOLUTION

An appeal can be lodged to the Rectorate of UPV to reconsider this official announcement, the rules and resolution, which exhausts the legal channels, within one month from the day following the notification, according to the terms established in Articles 123 and 124 of Law 39/2015 of October 1st on the Common-Administrative Procedure of the Legal Regime of Public Administrations or by a contentious administrative appeal of the Comunidad Valenciana within two months from the day following the

notification of this resolution, according to the terms established in Articles 14 and 46 of Law 29/1998 of July 13th, which regulates Contentious-Administrative Justice.
